ASSESSMENT FOR DRAINAGE RATES AND SPECIAL LEVIES
FOR THE YEAR ENDING 31ST MARCH, 2024

On 23rd January, 2023 the Board resolved,

1. that in respect of the financial year ending 31st March 2024, the proportions of its expenditure to be raised by Drainage Rates with regard to agricultural land and/or buildings and by Special levies on the local billing authorities be 21.88% (£308,816) and 78.12% (£1,102,402) respectively.
2. to make the Drainage Rates and Special Levies as set out below and that the official seal of the Board be affixed to those drainage rates and special levies.


