On 30<sup>th</sup> January 2024 the Board resolved,

1. that in respect of the financial year ending 31<sup>st</sup> March 2025, the proportions of its expenditure to be raised by Drainage Rates with regard to agricultural land and/or buildings and by Special levies on the local billing authorities be 18.36% (£274,926) and 81.64% (£1,222,098) respectively.
2. to make the Drainage Rates and Special Levies as set out below and that the official seal of the Board be affixed to those drainage rates and special levies.
